1.0 SUMMARY

In October 2009 and May 2010, Swale and Thames Archaeological Survey Company (SWAT Archaeology) carried out an Archaeological Watching Brief of a proposed development site at land adjoining Oak End, 1 High Street, Sevenoaks, Kent TN13 1HY. (Fig 1). The works were carried out on behalf of BHD Architects LLP during machine stripping of topsoil (October 2009) in advance of the construction of housing and the cutting of foundation trenches and other groundworks (May 2010). Planning Application Number: SE/09/00753).

The Watching Brief revealed no archaeological features.

2.0 INTRODUCTION

2.1 Planning Background

A planning application (PAN:SE/09/00753) for the construction of a deteched two storey four bed dwelling was submitted to Sevenoaks District Council. Kent County Council Heritage and Conservation (KCCHC), on behalf of Sevenoaks District Council requested that an Archaeological Watching Brief be undertaken in order to record any archaeological remains uncovered during associated groundworks. The following condition was attached to the planning consent:

9. No development shall take place until the applicant, or their agents or successors in title, has secured the implementation of a watching brief to be undertaken by an archaeologist approved by the Local Planning Authority so that the excavation is observed and items of interest and finds are recorded. The watching brief shall be in accordance with a written programme and specification, which ahs been submitted to and approved by the Local Planning Authority.

2.2 Schedule of Visits

An Archaeologist attended the site and monitored excavation works on the following dates:

6th October 2009 7th October 2009 4th May 2010

2.3 Aims and Objectives

The purpose of the monitoring and recording, as specified by Kent County Council was to:

'contribute to the heritage knowledge of the area through the recording of any archaeological remains exposed as a result of excavations in connection with the groundworks. (KCC 2009:3.1)

2.4 Proposed Groundworks

The groundworks involved;

- A strip of the topsoil
- Excavation of any trenches for services and drainage
- Any other ancillary groundworks associated with the application

2.5 Confidence Rating

No factors hindered the recognition of archaeological and geological deposits during the monitoring and recording exercise.

3.0 ARCHAEOLOGICAL & GEOLOGICAL BACKGROUND

The underlying geology at the site according to the British Geological Survey map is Folkestone Beds (KCC 2009:1.7). The topsoil sealing the Folkestone Beds had a maximum thickness of 24cm. Topographically the site is a suburban garden. According to the County HER the site lies within the medieval and post medieval settlement of Sevenoaks with several properties from these periods within the vicinity.

4.0 METHODOLOGY

The Watching Brief was conducted in accordance with the specification compiled by Kent County Council Heritage and Conservation and it also complied with the Institute of Field Archaeologists' *Standards and Guidance for Archaeological Watching Briefs* (1999). The works comprised the observation of all groundworks, including the inspection of subsoil and natural deposits for archaeological features and finds.

5.0 RESULTS

5.1 General

The site, formerly gardens and lawn was stripped of it's topsoil by machine (Plates 1-2). The topsoil was about 24cm. The removal of the topsoil revealed the subsoil of Folkestone Beds. Continued machining of the subsoil to a maximum depth of 30cm revealed no archaeological features and just the natural geology.

5.2 Deposit Model

A common stratigraphy was revealed across the entire site:

0.00m-0.24m Topsoil and grass.

0.24m-c.1.65+ Subsoil of Folkestone Beds.

No archaeological features were recorded.

6.0 FINDS

No archaeological features present and no finds were retrieved.

7.0 DISCUSSION

The Archaeological Watching Brief carried out at Oak End revealed that no archaeological features were present.

8.0 CONCLUSION

The Archaeological Watching Brief has fulfilled the primary aims and objectives of the Specification. No buried archaeological features have been affected as a result of the development.
